To determine whether a presumption of abuse arises, all individual debtors with primarily consumer debts who file a chapter 7 case must complete Official Bankruptcy Form B22A, entitled "Statement of Current Monthly Income and Means Test Calculation - For Use in Chapter 7." ### **Filing Requirements for Chapter 7 | District of Columbia ...**

U. Statement of Intention for Individuals Filing Under Chapter 7 (Official Form 108) - this form must be filed within 30 days from filing of the bankruptcy case or by the date set for the meeting of creditors [11 U.S.C. § 521(a)(2)(A)].

### **Chapter 7 Petition Package (Individual Debtors)**

The debtor must file a signed Official Form 103B: Application to have the Chapter 7 Filing Fee Waived and Schedules I and J for the court's approval. DOCUMENTS MUST BE FILED WITHIN 14 CALENDAR DAYS OF FILING THE PETITION UNLESS OTHERWISE INDICATED. YOUR CASE MAY BE DISMISSED IF YOU DO NOT FILE THE REQUIRED DOCUMENTS ON TIME.
