Restatement (2d) of Torts § 558. Elements Stated To create liability for defamation there must be: (a) a false and defamatory statement concerning another; (b) an unprivileged publication to a third party; (c) fault amounting at least to negligence on the part of the publisher [with respect to the act of publication]; and

### **Restatement (2d) of Torts**

Since 1964, with the decision of *New York Times Co. v. Sullivan*, 376 U.S. 254, the Supreme Court has held that the First Amendment has placed a number of substantial restrictions on tort actions involving false and defamatory publications. These restrictions are treated in Division Five of this Restatement.

### **Restatement of the Law, Second, Torts, § 652**

Restatement (Second) of Torts, section 321: "(1) If the actor does an act, and subsequently realizes or should realize that it has created an unreasonable risk of causing physical harm to another, he is under a duty to exercise reasonable care to prevent the risk from taking effect.
